



## Junior Golf Financial Aid Information

Thank you for your inquiry regarding our youth scholarship program for Everett Junior Golfers. The City of Everett Parks and Recreation Department believes that access to a full range of recreational opportunities is essential to every child's well being. To help ensure that, we offer scholarships to financially needy youth through the Joe Richer Golf Club to help subsidize their registration and green fees for Everett's Junior Golf Program.

Enclosed is a scholarship form. Please take a moment and fill it out. You will notice that we ask for a copy of your child's *current* free or reduced school lunch approval letter. This letter helps us determine eligibility for financial aid. *If you do not have such a letter, please include any documentation that may help us determine your income level* (a copy of the most current year's income tax return, current copies of any assistance checks that you may receive, etc.).

## General Policies

Scholarships can only be awarded to children 18 years of age and under.

\*Applicant must live in the City of Everett.

Applicant must qualify under the Family Income Guidelines listed in this brochure.

Financial Aid applies only to Everett Parks Department sponsored Junior Golf Programs and the Joe Richer Junior Golf Club.

Scholarship/Fee reduction privileges expire December 31<sup>st</sup> each year. Recipient may apply for more funding again in January.

The Foundation's ability to give financial aid is solely dependent on charitable contributions; therefore we cannot guarantee that all eligible applicants will be funded. Based on available funds, applicants will be funded on a first-come, first-served basis.

Incomplete applications will not be considered.

Some activities may be exempt from funding, at the discretion of the Everett Parks Department and the Greater Everett Community Foundation.

\* Non-Resident applications will be considered based upon available funds.
